Princess drop Dawn tips

PRINCESS Cruises will do away with automatic passenger tipping on its 2011 World Cruise aboard *Dawn Princess* - the first Princess voyage to operate from Australia without the service charge.

The announcement comes as Princess Cruises begins selling cabins for its 2011 104-night World Cruise aboard *Dawn Princess* that sets sail from Sydney and visits 43 destinations around the globe.

Senior vice president of Carnival Australia Jenny Lourey said the World Cruises receive wonderful feedback from Aussies as they are tailored to our market.

She said Princess' decision to erase the normal \$10pp per day gratuity for Australian and New Zealand guests onboard accounts would meet local demand.

QF A380 MEL/LHR

QANTAS has today announced it will launch A380 services between Melbourne and London, via Singapore from 18 Jan following the arrival of its fifth superjumbo (*TD* yesterday) and the delivery of its sixth in coming days.

QF will operate up to 2 flights per week with the A380 to London on QF9 on Mon and Sun, and QF10 on Fri and Sat.

When the sixth Airbus A380 comes online Qantas will ramp up superjumbo services from 29 Mar as follows: Sydney-Los Angeles will operate daily (up from the current 4 p/w); Sydney-Singapore-London will be 5 p/w; Melbourne-Los Angeles will increase to thrice weekly (up from twice weekly) and MEL-SIN-LHR twice weekly.

The 5th A380 has been named *Lawrence Hargrave* and the 6th has been dubbed *Charles Kingsford Smith*.

More Xmas piccies

Lourey said, "Because this cruise sails from Australia and attracts an overwhelming Australian clientele, we've changed our tipping policy on this cruise to reflect local community expectations," said Lourey.

The move will save couples booking the six continent 104-night World cruise over \$2,000.

A spokesperson for Carnival Australia told *TD* that the removal of the tipping levy was a feature of this cruise only and would not be offered on other cruises.

Departing in May 2011, *Dawn* will make maiden calls to 12 ports - Abu Dhabi, Amsterdam, Ashdod, Bergen, Cartagena, Casablanca, Dover, Edinburgh, Lisbon, Fort Lauderdale, Petra and Puntarenas.

Fares for the World Cruise lead in at \$20,799ppts, which takes into account Early Booking Saver deals of up to 45%, when booked by 31 May 2010.

Another UK collapse

A MAJOR travel wholesaler in the UK has ceased trading, with the failure following the collapse last week of Scottish carrier Flyglobespan (TD Thu).

The Allbury Travel Group operated a number of brands including Libra Holidays, Argo Holidays and Jetlife, and reportedly had more than 4000 forward bookings for its package holidays and flights.

Allbury's products were sold mainly through British travel agents and included trips to Greece, Cyprus and Egypt.

The BBC has reported that both Allbury and Flyglobespan used the same credit card processor, a company called E-Clear, with the Flyglobespan administrator questioning why the financial services provider withheld around £30m from the carrier.

MEANWHILE, Madrid-based Air Comet has announced it was ceasing operation after a British court banned the airline selling tickets due to debts of over \$25m.

Air Comet operated scheduled services to Latin American cities including Buenos Aires, Lima, Quito, Bogota and Mexico City.

NZ pax no's down

AIR New Zealand transported 951,000 passengers in Nov, or 0.6% less than the year prior, according to its latest stats released today.

Demand was down 3.7%, while capacity was reduced by 10.2%.

Qantas defends BA JSA

QANTAS has responded to matters raised by both Air New Zealand and Emirates in relation to the proposed renewal of the Joint Services Agreement which allows it to coordinate operations with British Airways (TD 09 Dec).

Air NZ commented that any re-approval of the JSA should be specifically limited to cooperation on routes between Australia and the UK via Asia, but QF and BA have insisted that the JSA is a

Eurostar probe

THE board of cross-channel rail operator Eurostar has commissioned an independent review into the crises it has experienced this week (TD yest).

Restricted Eurostar services will operate from today until Christmas for guests who hold a ticket issued up until 24 Dec.

Customers without confirmed bookings are being advised not to attempt to use the Chunnel until beyond Christmas.

Kukuma for families

KUMUKA Worldwide has added new Family Adventures in Fiji, Canada, Oman and Jordan to its 2010-11 product range.

The brochure features 57 trips in total which, according to the tour operator, "facilitate the management of travelling as a family and take into account the different needs and views of each family member."

QF and BA said the JSA is currently not limited to coordination on specific routes and even though currently it's only used on the Kangaroo route - and therefore should be renewed in its current form.

And in response to Emirates' assertions about its premium passengers being fed to markets other than just the UK, QF and BA point out that the significant expansion plans of Emirates allow it to feed passengers to a range of destinations including the UK.

The JSA partners say that the ACCC should be comforted that if they were hypothetically able to increase prices above competitive levels ex-Australia, "strong and vigorous competitors such as Emirates have the existing capacity and immediate ability to increase the amount of tickets they make available for sale ex-Australia."

"This will in turn defeat any hypothetical price increase and demonstrates the practical constraint on the JSA going forward," the QF submission said.

Qantas also notes comments by Emirates about multilateral airline alliances but downplays an EK suggestion that the JSA is able to "fundamentally alter the competitive landscape."

"To the extent that the JSA as a bilaterally arrangement does affect competition, it does so in a pro-competitive manner, to the benefit of consumers," said Qantas General Counsel, Brett Johnson.

The 23-year-old ate a meal at the eatery but then threatened the owner's daughter with a knife - at which point the other diners overpowered him.

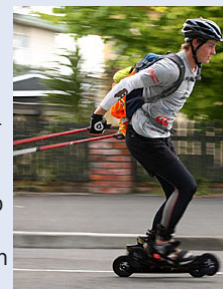
They called the police, but when officers arrived the offender jumped to his feet and revealed his 'explosive' belt.

Thanks, but how?

THE Hotel, Motel and Accommodation Association says it supports the National Long Term Tourist Strategy, announced by Minister for Tourism Martin Ferguson last week (*TD* Tue), but says it needs direction for adopting change.

He has called for an investment in tourism infrastructure to meet the changing needs of consumers, such as 3-star hotels upgrading to 4-star, but the HMAA chief exec Lorraine Duffy said, "Although the Long Term Tourism Strategy is to be applauded, it is still not clear how this particular issue will be tackled and financed."

GOH Calypso-Net

GARUDA Orient Holidays has integrated Moneydirect into its Calypso-Net page, making it more convenient for travel agents to pay for tour bookings.

The change means agents will no longer need to leave Calypso-Net and log-on to the Moneydirect website to make a payment, with the firm's saying it will also speed up the documentation process.

Agents interested in using the Moneydirect payment tool will need to register with GOH.

ANA orders 10 jets

ALL Nippon Airways has ordered five 777-200ER and five 767-300ER jets with Boeing worth about \$US2.1 b, to meet demand at its Tokyo Haneda airport hub.

To be delivered between 2010 and 2014, the order comes at the same time rival Japanese carrier JAL looks at downsizing its ops.

BNE expect record

BRISBANE Airport Corporation Ltd says its heading for a record Christmas this year, with around 370,000 international and 1.3 million visitors expected to use the airport during Dec.
