POLICIES

These policies apply to bookings which are voluntarily cancelled by clients. For passengers affected by the suspension of cruises across the next few weeks, there are different cancellation policies, which Travel Daily and Cruise Weekly will detail elsewhere.

Carnival Cruise Line	30 days prior	Cruises departing through to end of May 2020	Future cruise credit for sailings with one year of original sailing day

Cunard	48 hours prior	Cruises departing prior to 31 Aug 2020	Future cruise credit equivalent to the cancellation fees and refund on all monies paid. Future cruise credit can be redeemed on bookings before 31 Dec 2021 for travel until end of March 2020

Holland America Line	72 hours prior	Cruises departing prior to 31 May 2020	Full cruise credit must be redeemed by 31 Dec 2020 for any cruise in 2020 or 2021
Hurtigruten	Rebook by 30 Apr	Cruises departing between 20 Apr and 30 Sep 2020	Full cruise credit plus 10% discount on your new voyage when rebooked by 30 Apr for future sailings between 01 Jul 2020 and 31 Dec 2021

Oceania Cruises	48 hours prior	Existing and new bookings made by 30 Apr 2020 for voyages departing between 10 March to 30 Sep 2020	Future Cruise credit + up to the day of sailing should their be another applicable public promotion that offers better value guests can take advantage of the new deal

Princess Cruises	48 hours prior	Cruises booked to 31 Jul 2020	Refund and future cruise credit for the amount of the cancellation fee to be used on any cruise departing by 31 Dec 2021

Viking Cruises	24 hours prior	Any cruise in 2020, 2021 and 2022 including those booked before 30 Apr 2020	Free to postpone their cruise and receive a future cruise voucher valid for 24 months
